





Addition of permanent "Modified Assessment" Journal Type - effective May 12, 2023

New Journal Note Effective May 12, 2023

- Best practice for all assessments is via in-person modality
- "Modified Assessment"
 - added to Aging & Disability effective May 12, 2023
- Examples of when to use "Modified Assessment"
 - RN completes annual re-determination via Hybrid Model
 - Part of the assessment completed telephonically / part completed in-person
 - Consumer requests reassessment be completed via telephonic means
 - Case Manager completes reassessment via telephonic means
 - Utilizes resources available to complete reassessment
 - Provider Agency
 - Any formal / informal supports available







COVID19 Critical Incident Reporting

COVID19 Critical Incident Reports Ended May 11, 2023

- > ASAPs are no longer required to submit CIRs for consumers who tested positive or subsequently passed away from COVID19.
- ➤ EOEA has been tracking COVID19 positive consumers via CIRs since March 2020.



Nursing Flexibilities Home Health Aide Updates & MassHealth Guidance

Nursing Flexibilities End Effective May 11, 2023

Programmatic Considerations for CAE, CSSM, and OC is rescinded

Ends flexibility to conduct desk review (paper screening) to determine clinical eligibility for MassHealth payment of nursing facility services

ASAPs must complete NF screenings in accordance with PI 22-07 – Clinical Assessment and Eligibility for Nursing Facility Assessments

- All nursing facility screenings require an on-site assessment except for the exceptions listed in PI 22-07
- When no on-site assessment is performed the ASAP RN will utilize the Nursing Determination Module for rendering a clinical determination
- When an on-site assessment is performed the ASAP RN will utilize either the CDS-RN or the CDS-NF as indicated within the PI

Flexibilities related to Home Health Aides*

Home Health Aide Supervision:

- Effective May 11, 2023: MassHealth has ended the flexibility waiving supervision requirements
- Providers must comply with the supervision requirement outlined in 130 CMR 403.416(A) Conditions of Payment
- Under EOEA authority supervision flexibility was extended to Personal Care Homemakers, Homemakers & Supportive Home Care Aides in Massachusetts



Flexibilities related to Home Health Aides*

12-Hour Annual Home Health Aide In-Service Training Requirement:

- Following the end of the federal PHE, providers will have through the first full quarter (September 30, 2023) after the end of the federal PHE to comply with 12-Hour Annual In-Service Training Requirement for home health aides
- Under EOEA authority training flexibility was extended to Personal Care
 Homemakers & Supportive Home Care Aides in Massachusetts
 - NOTE: In accordance with CMS Guidance issued 5/10/2023 In-service training requirements will return to pre-PHE requirements at the end of the calendar year that the PHE ends EOEA is applying this additional guidance to Supportive Home Care Aide & Personal Care Homemaking In-Service Training Requirements

Interim Provider Actions Previously Rescinded


Interim Actions for Provider Procurement (Flexibility ended 6/15/2021)

- Flexibility regarding advertising in a newspaper
- ASAP is required to advertise the Request for Procurement (RFP) for their 3 year contracting cycle

Interim Actions for Provider Monitoring (Flexibility ended 4/2022)

- Suspended provider monitoring activities until 90 days following the state PHE except in instances:
 - abuse,
 - neglect,
 - immediate jeopardy concerning a participants health & welfare
- Required to complete Provider Monitoring
 - released virtual/hybrid audit capabilities
 - EOEA addressed Provider Monitoring Plan at Contract Managers meeting 4/20/23
